**MARKET SURVEY NOTICE**

**For the expression of interest to participate in the negotiated procedure (according to the Italian Legislative Degree 18 April 2016, no. 50) for the supply of a Skid-mounted Thin Film Evaporator Pilot Plant in Trisaia ENEA Research Centre.**

The Italian National Agency for New Technologies, Energy and Sustainable Economic Development (hereafter also “ENEA” or “Agency”) – Lungotevere Grande Ammiraglio Thaon di Revel, n. 76 – 00196 Roma - URL <http://www.enea.it> - Codice NUTS IFT52, intends to make a market survey to set up a list a qualified economic operators to be invited to a procedure for the acquisition of the above mentioned supply.

This notice is not tender procedure, and there will not be merit ranking or scoring and it will not establish any legal obligations, ENEA reserves the right to suspend, modify or cancel, in whole or in part, this procedure without any possibility to claim for any compensation.

The Agency reserves the right to proceed with the negotiated procedure even in case of only one valid expression of interest.

**1. Content of the procedure**

The procurement relates to the supply at the Trisaia ENEA Research Centre of **a thin film evaporator pilot plant for the separation of a mixture containing monomers (1-decene and 9-DAME) and oligomers (poly-alpha olefins).**

A detailed description of the supply is reported in the enclosed document “**Technical Specifications for the suppling of thin film evaporator pilot plant**”, ENEA, TERIN-BBC, October 2020.

## 2. Duration and Economic Value of the Contract

The duration of the contract is within **9 months** from the real beginning of activities.

The contract amounting is estimated to be **€ 350.000,00 + VAT**.

## 3. Tender Award Criteria

In case the negotiated procedure will be launched, the contract will be awarded to the most economically advantageous offer, taking into account the best quality-to-price ration, pursuant to Italy's art. 95, paragraph 3 letter b-bis of Legislative Decree 50/2016 and subsequent amendments, measurable as:

- Technical value max 70/100 points
- Economic value max 30/100 points

## 4. Requirements for the Admission to the tender

Only the economic operators that will meet all of the following criteria will be invited to participate to the negotiated procedure:

- a) The economic operator must satisfy the requirements reported by the Italian Legislative Decree 50/2016 and subsequent amendments (see art. 45 and 80)
- b) The economic operator must satisfy the following **professional requirements**:
  - b.1) Registration to the Chamber of Commerce, in the category relevant to the tender object. The economic operator that is not established in Italy shall submit an affidavit or a declaration proving to be registered to the corresponding Chamber of Commerce of the State in which it is established;
  - b.2) The economic operator must have UNI EN ISO 9000 Quality System Certifications released by accredited entities;
- c) The economic operator must have done in the last five years at least three projects concerning the design and/or manufacture/fabrication/commissioning of pilot plants for development and optimization of chemical processes relevant to the tender object;
- d) The economic operator must declare to have achieved during the last five years and for at least one year an economic turnover higher or equals to **350.000 €** (VAT not

included), related to projects in the field of the scope of the tender, indicating the details of the supplies.

- e) The economic operator must declare to have the necessary human and technical resources and experience to perform the contract to the appropriate quality standard, at least the presence of a project manager with master degree and at least three years of experience in the management of projects with economic value higher or equals to the opening bid.

## 5. Terms and Conditions for submitting the expression of interest

**The procedure will be handled on electronic platform.**

The economic operator shall access U-BUY eProcurement platform by signing up to obtain the login information for the Reserved Area in the Public Contracts Portal at the web page: <https://enea.ubuy.cineca.it/PortaleAppalti/it/homepage.wp>.

In the event that the documents could not be digitally signed, the above documents shall be accompanied by a copy of declarant’s identity document.
